The difference in focus of concern and courses of action may be extrapolated to many Third World or developing nations, and leads to provocative questions regarding policymaking for public participation in future environmental campaigns. Descriptive views from the authors, eloquent and moving testimony from members of the community, and clear statistical analysis of the findings make this book a highly readable text. **People and Pollution** is a pioneering and important work that should be consulted by environmentally concerned readers, students, and policymakers alike.

The new perspective attached a more significant role to external factors in the democratization process than was originally conceptualized.

#### **THE LIMITS OF CHOICE**

Penn State Press *Autonomy* is fundamental to liberalism. But autonomous individuals often choose to do things that harm themselves or undermine their equality. In particular, women often choose to participate in practices of sexual inequality—cosmetic surgery, gendered patterns of work and childcare, makeup, restrictive clothing, or the sexual subordination required by membership in certain religious groups. In this book, Clare Chambers argues that this predicament poses a fundamental challenge to many existing liberal and multicultural theories that dominate contemporary political philosophy. Chambers argues that a theory of justice cannot ignore the influence of culture and the role it plays in shaping choices. If cultures shape choices, it is problematic to use those choices as the measure of the justice of the culture. Drawing upon feminist critiques of gender inequality and poststructuralist theories of social construction, she argues that we should accept some of the multicultural claims about the importance of culture in shaping our actions and identities, but that we should reach the opposite normative conclusion to that of multiculturalists and many liberals. Rather than using the idea of social construction to justify cultural respect or protection, we should use it to ground a critical stance toward cultural norms. The book presents radical proposals for state action to promote sexual and cultural justice.

Routledge *Diaspora* politics is often expressed as an emancipating experience and can therefore give agency to migrants. Yet, rather than interpreting transnational political practices as globally liberal or cosmopolitan, Müller-Funk's findings underline that diaspora politics is a highly diverse political field which can reinforce political fragmentation among migrant collectivities. This volume explores the controversial topic of diaspora politics: the political activities of migrants who aim to influence the domestic or foreign policy



of their country of origin. The revolutions in 2010/11 represented a major political upheaval in the Middle East, which politicised Arabs across borders on a grand scale. Müller-Funk explores the links between recent political developments in Egypt between 2011 and 2013 and emigration. More specifically, she examines the question of how the revolution in and its aftermath influenced emigrants' political perceptions and actions regarding their homeland. The book takes an interdisciplinary macro and micro approach by investigating policies which influence migrants' political transnational behavior as well as by looking at individual activists' perspectives. This volume will be of great interest to scholars of international relations, security studies, political theory, politics and middle east studies.
