The main areas covered are: the law; types of lift truck; lift truck operators; training; authorisation to drive; the working area; protecting pedestrians and operators; operation of lift trucks; trailers and loading platforms; maintenance; and two appendices covering training bodies and medical standards for lift truck operators.
